- 2. Fax a copy of your invoice (i.e., proof of purchase) for your new Intermec equipment and a rebate coupon to Intermec Rebate Processing at 905.673.3974.
- 3. Upon receipt of your rebate coupon and invoice, Intermec will email you a confirmation along with detailed instructions for shipping your trade-in equipment.
- 4. Once the rebate coupon, invoice and trade-in equipment have been received (at the location instructed in the email), a rebate check will be issued to the product end user. The total amount of the rebate depends on the unit(s) traded in, as well as the new products purchased.
- 5. Shipments of trade-in equipment must be postmarked within 30 days of invoice for the new Intermec equipment. Example: if the new Intermec equipment has an invoice date of April 1, 2010, the trade-in equipment must be shipped no later than May 1, 2010.
- All trade-in equipment must be received by Intermec no later than January 31, 2011 in order to be eligible. Any exceptions must be requested in writing prior to January 15, 2011.
