How it works

1. Purchase a qualifying Intermec printer and trade in either an Intermec or competitive printer through December 31, 2010. Your rebate will be based on a 1:1 ratio of eligible units you trade-in to the eligible new units you purchase. Purchases must be made from an Intermec authorized source.

4. Once the rebate coupon, invoice, and a copy of the shipping label have been received by the Rebate Headquarters and the trade-in equipment and copy of the rebate coupon have been received by the Returns Center, an email confirmation will be sent to the address provided on the coupon.
5. A rebate check will be issued to the product end user. The total amount of the rebate depends on the unit(s) traded in, as well as the new products purchased. Allow 10-12 weeks for processing.
6. Shipments of trade-in equipment (Step #3) and submission of rebate coupon (Step #2) must be postmarked within 30 days of invoice for the new Intermec equipment. Example: if the new Intermec equipment has an invoice date of April 1, 2010, the trade-in equipment must be shipped and rebate coupon sent no later than May 1, 2010.
7. All trade-in equipment must be postmarked no later than January 31, 2011 in order to be eligible.
